FULL TERMS AND CONDITIONS

NOT INCLUDED:

There is a \$59 set up charge for printing Invitations. Should you wish to print on the reverse side of the invitations a fee of \$50 will apply. As there is 1 free invitation given for each gown set ordered, extra invitations will be invoiced at \$0.50 each including envelopes. Numbering of invitations is available for a \$50 fee.

FREE INCLUSIONS:

Schools ordering 100 or more items will receive 1 Free Valedictorian Stole, 1 Free Valedictorian Medal and 1 Free Award of Distinction. Schools ordering less than 100 items can purchase all 3 of these for a flat \$65 fee. Extra Valedictorian Medals and Stoles can be purchased for \$50 per pair. Extra Awards of Distinction can be purchased for \$50 each. Free inclusions must be chosen by March 1st to guarantee availability.

ALL APPLICABLE TAXES AND SHIPPING CHARGES EXTRA.

DEADLINES OF ORDER: BOOKING FORM:

We suggest your booking form be submitted immediately in order to guarantee that availability of your gowns. Without a booking form there is no guarantee of availability. Sizing will not be required at this time.

PRELIMINARY SIZING:

It is **reccomended** to have preliminary orders submitted by March 1st to guarantee availability for May/June commencements. However, orders can be submitted at any time, subject to availability on first come first serve basis from our inventory. Preliminary sizing must be submitted using either our size summary form or excel file. All graduation regalia is custom made and brand new for each student so time is required for manufacturing. Schools are recommended to order a graduation gown for each graduation candidate with preliminary sizing and to delete non graduating students upon final sizing. This alleviates the need for late ordering, additional shipping charges as you know a gown has been ordered for each student.

FINAL SIZING:

Changes to preliminary sizing can be done at any time provided the appropriate sizes are in stock. Schools are allowed to cancel up to 10% of their preliminary order without penalty.

GOWN SIZES AND FULL FIT:

All sizing on the order form is based on regular fit gowns. We offer FF (FULL FIT) gowns for students that require them at no additional cost. These gowns must be ordered with preliminary order in order to guarantee their availability. It is strongly suggested to order full fit gowns as extras to have on hand.

DEPOSIT & PAYMENT:

No deposit is required, however Payment in full MUST be either PREPAID or COD, unless previously arranged. Purchase orders can be submitted but must be done so payment can be received prior to or upon delivery.

DISCREPANCIES:

Any discrepancies in goods shipped MUST be reported within 24 hours of delivery, such as shortage, overage, etc. Any time after this 24 hour period we will not assume any responsibility. PLEASE CHECK YOUR ORDER OVER UPON RECEIPT TO AVOID ANY DISCREPANCIES
